JUDGMENT ENTRY OF
GENERAL CONDITIONS OF
COMMUNITY CONTROL

It is the Order of this Court that you are to follow the advice and direction of the Ottawa County Adult Probation Department, and shall comply with the following General Conditions of Community Control (Probation):

- 1) You shall abide by the laws of the United States, the State of Ohio, the Political Subdivisions of Ohio, and be of general good behavior.
- 2) You shall not leave the State of Ohio without first obtaining the written consent of the Court or the Ottawa County Adult Probation Department.
- You shall not possess, consume, purchase, or have under your control alcohol beverage, any narcotic or controlled substance unless prescribed to you by a doctor. You shall not associate with any known illegal possessor, trafficker, or user of any controlled substances,. Further, you shall not have under your control instruments for the administration or use of controlled substances.
- 4) You shall not enter any bars or taverns, unless given written permission by the Adult

Probation Department..

- You shall advise medical providers that you are subject to drug testing and that controlled substances should be avoided when possible. You shall provide the Adult Probation Department with a copy of any prescriptions within 24 hours of receiving said prescription. Prescriptions shall be taken as prescribed and may not be taken beyond the period for which it was prescribed.
- 6) If you are subject to a pain management contract, the Adult Probation Department shall be provided a copy of said contract within 24 hours of execution.
- 7) Under the direction of the Adult Probation Department, you are subject to random testing for the consumption of alcohol and drugs. Upon each examination, you shall pay the costs of said testing as well as any laboratory fees.
- 8) You shall immediately report to the Ottawa County Adult Probation Department if you are arrested, detained or questioned by any law enforcement officer.
- 9) You shall not visit inmates in any County Jail or any other State or Federal penal facility without the prior written consent of the Ottawa County Adult Probation Department. You shall not associate with persons on probation supervision or community control, known felons, persons under indictment, persons who have criminal charges pending in any court, or persons of disreputable or harmful character.
- You shall neither carry, possess, own, nor have under your control any deadly weapon, dangerous ordnance or firearm, and in the case of a conviction for an applicable Misdemeanor offense, you may only do so with the written consent of the Ottawa County Adult Probation Department.
- 11) You shall in good faith become and remain gainfully employed and support your legal dependants. If you should become unemployed you must in good faith seek to become re-employed. Any change in employment status must be immediately reported to the Ottawa County Adult Probation Department.
- 12) You shall promptly and truthfully answer all inquiries directed by the court or Ottawa County Adult Probation Department.
- 13) You shall abide by a curfew and be in <u>your</u> residence between the hours of 10:00 p.m. and 6:00 a.m, unless given written permission by the Probation Department, Further, you are subject to electronic monitoring to insure compliance with this condition.

- 14) You are subject to Electronic Monitoring, GPS Monitoring or SCRAM monitoring at the discretion of the Adult Probation Department.
- 15) You shall notify the Ottawa County Adult Probation Department prior to any change of address and, shall not be without a residence, and may be forbidden to reside at certain locations.
- 16) You shall immediately report any change in telephone number to the Probation Department.
- 17) You shall pay all fines and/or costs of prosecution including any Community Control supervision fee(s) on a payment schedule as established with the Ottawa County Clerk of Court. Said period not to exceed the Court Ordered term of community control.
- 18) You shall report to the Ottawa County Adult Probation Department as directed by the Probation Officer. You will be prompt to all appointments and shall not be excused from any appointment without prior permission of the Probation Officer.
- 19) You shall submit to D.N.A. testing, to be conducted by the Ottawa County Adult Probation Department, and in accordance with section 2901.07 or 2152.74 of the Ohio Revised Code.
- 20) You shall have no involvement with gang activity. This includes the wearing of colors or hats associated with gangs, writing or displaying graffiti, using gang signs, and associating with gang members.
- You shall not be employed by or receive compensation as a special agent, nor shall you work in any capacity as an informant for any federal, state or local governmental entity. However it is your duty to relay any information regarding any criminal activity, within your knowledge, to any federal, state, or local governmental agency, under the direction of the Ottawa County Adult Probation Department.
- 22) You shall not wear any clothing which advertises or promotes the use of alcohol or illegal drugs.
- During the period of supervision, any officer of the Ottawa County Adult Probation.

  Department or any properly appointed supervising agency/officer, within the scope of their supervisory duties or responsibilities, may search with or without a warrant your person, place of residence, motor vehicle, any other item of tangible or intangible property, or other real property in which the Defendant may have a right, title, or interest or for which you may have the expressed or implied permission of a person

with a right, title, or interest to use, occupy, or posses, if the Ottawa County Adult Probation Department has reasonable grounds to believe that you are not abiding by the law or otherwise not complying with any condition of Community Control.
